HISPANIC HERITAGE MONTH



Hispanic Heritage Month (9/15 to 10/15), is a way to celebrate the history, culture, and contributions of Hispanic-Americans — specifically, those whose ancestors came from Spain, Mexico, the Caribbean, and Central and South America.

September 15 is set as the starting date for the month as it is important for many reasons. It is the independence anniversary for Latin American countries El Salvador, Guatemala, Costa Rica, Nicaragua, and Honduras. From here onwards, the independence days of Mexico and Chile fall on September 16 and September 18, respectively. Dia de la Raza or Columbus Day also falls within this month, on October 12. Hispanic Americans have been integral to the prosperity of the U.S. Their contributions to the nation are immeasurable, and they embody the best of American values. 
GERMAN-AMERICAN HERITAGE MONTH

LET'S ENCOURAGE VOTING IN GEORGIA



Gov. Brian Kemp signed <u>Senate Bill 202</u> on March 31. Since then, the Justice Department <u>has filed a lawsuit</u> against the State of Georgia to stop racially discriminatory provisions. See below for important highlights of SB202:

- The law expands in-person early voting for general elections. Two early voting periods are required on a Saturday for each county, with optional voting on Sunday. In prior elections, early voting began on the fourth Monday before a primary or election and ended the Friday before an election day, according to the state's official website. For runoff elections, voting began as soon as possible before election day.
- The deadline for the issuance of to request absentee ballots has been moved up and is now at least 25 days before a federal primary, general election, or special election or 22 days before a municipal general election or primary
- A Georgia state driver's license number or, ID card number, date of birth, and the last four digits of a social security number or
 another approved form of identification must be printed on the outside of an absentee ballot. Georgia is now one of only four states
 in the US with this requirement.
- Conditions for rejecting absentee ballots if certain requirements are not met
- The law bans people aside from poll workers from soliciting votes or signatures from voters. The distribution or display of campaign
 materials is also restricted to 150 feet of the "outer edge" of a polling location or within 25 feet of a person waiting in line to vote.
 Offering money and gifts including food or drink to a voter is prohibited.

Our group is working on ways to partner up with other organizations to increase access to voting in Georgia. Stay tuned for opportunities to help!

EVENTS AND OTHER UPDATES

- Emory Healthcare names its first chief diversity, equity, and inclusion (DEI) officer: Emory Healthcare has named Ildemaro González as its first chief DEI officer. He assumed this role as of Sept. 13, 2021. Find more information here.
- **Día de Muertos 2021- Day of the Dead:** the Atlanta History Center has its annual celebration on October 31st from 12–5 pm. While the event is free and open to the public, capacity is limited, and advanced <u>registration is required</u>.
- Octoberfest in Helen, Georgia: Alpine Helen's Oktoberfest celebrations have been going on for 50 years, involving multiple weeks of traditional dancing, food, and, of course, beer from September to November. Held in the city's riverside Festhalle, the

permanent home of the festivities, the celebration is the longest-running of its kind in the United States. Find more information here.

The <u>Atlanta Pride Festival</u> was canceled this year due to the COVID-19 pandemic.

DID YOU KNOW?

The fastest population growth among U.S. Latinos has come among those with origins in Venezuela, Guatemala, and Honduras. From 2010 to 2019, the Venezuelan population in the U.S. increased 126% to 540,000, by far the fastest growth rate. Guatemalans saw an increase of 49%, followed by a 47% increase among the Honduran population. By contrast, the number of people of Mexican origin grew by only 13% from 2010 to 2019, among the lowest growth rates in the top 10 origin groups. At 6%, the Ecuadorian population saw the slowest growth rate among the top origin groups.

EVENT RECORDINGS AND PUBLICATIONS

- Emory conducted a Symposium discussing Emory's history of slavery and dispossession. Emory sits on land that
 belonged to the Muscogee (Creek) Nation, and enslaved people constructed buildings on the university's original
 campus. "In the Wake of Slavery and Dispossession," a symposium held from Sept. 29 Oct. 1, examined Emory's
 history and journey towards restorative justice. Find information about what was covered in the symposium here.
- Last year, President Gregory L. Fenves announced the <u>Descendants Endowment</u> to provide scholarships for two
 undergraduate students each year who descended from enslaved people with ties to Emory University. The first
 scholarship is anticipated for fall 2022.
